Our Park, Our Future! The Local Community's Statement and Requested Actions for the Airport to Park Conversion Project

November 7, 2023

Local Community's Position

The City of Santa Monica must "take all actions necessary and proper to ensure that SMO will cease to operate as an airport and shall be closed to all aeronautical use forever effective as of midnight on December 31, 2028." ¹

The people voted and the City must "prohibit new development on Airport land, except for parks, public open spaces and public recreational facilities, until the voters approve limits on the uses and development that may occur on the land." ² The City must not fund or start any development process that explores uses that are currently prohibited by Measure LC, nor should the City initiate a ballot measure to allow prohibited development on the land. Measure LC should not be manipulated to begin an illegal development process. ³

The City should focus on scenarios and concepts that are "centered around the idea of the site hosting a Great Park" ⁴ which include "parks, public open spaces, and public recreational facilities; and the maintenance and replacement of existing cultural, arts and education uses." ⁵

To do otherwise would demonstrate contempt for repeated and clear-cut election outcomes and democratic processes in the City of Santa Monica.

Requested Actions of City Council and Staff

We urge the Council and Staff to preserve and honor: (1) the original 1926 citywide vote to purchase the land for a public park, (2) the definitive 2014 Measure LC citywide vote that established Charter Amendment LC, and (3) the 2017 Consent Decree and 2017 City Council SMO Closure Resolution No. 11026 which ensures airport closure at midnight 12/31/2028.

Project Scope of Work Requests

We urge the City to explicitly direct Sasaki (the firm recommended by City Staff) to:

- 1. Focus on executing the vision and plan for a Great Park that is consistent with Measure LC and the original 1926 citywide vote to purchase the land for a public park.
- 2. Isolate and disclose any prohibited uses or development that may require prerequisite voter approval, before proceeding further with any prohibited development work, so its impacts are not hidden or blended among the alternative land use scenarios that are allowed.
- 3. Modify their RFQ and RFP submissions to <u>eliminate any direction that starts the</u> <u>development process that explores uses that are currently prohibited by Measure LC</u>. ⁶
- 4. Deliver at least one baseline concept for an Interim Park Plan with minimal changes, similar to Berlin's "Templehof model" as suggested in Staff Report 5503. ⁷ It should align with the airport closure date of midnight 12/31/2028, and soon after allow public use of the parkland, while incremental planning continues into the future.
- 5. Deliver a second baseline concept for a park that is financially self-funded and self-sustaining, which may use the existing annual \$20 million non-aviation lease revenue.
- 6. Determine the revenue that can continue when the airport is closed, and deliver a concrete plan to immediately identify and apply for Federal, State, and Local Park Grants.
- 7. Identify any land adjacent to Airport land that is not protected by Measure LC. 8

City Council SMO Closure Resolution No. 11026

WHEREAS, pursuant to the terms of the Consent Decree, the City has agreed to operate SMO with a runway of 3,500 feet until December 31, 2028, unless an earlier date is agreed to by the FAA and City; and

WHEREAS, initiation of the shortening of the Airport's runway to 3500 feet may commence upon 30-day prior notice to the FAA in accordance with 14 C.F.R. Part 157.5(b)(2); and

WHEREAS, the City Council desires that the City take all actions necessary to comply with the Consent Decree so that SMO will close effective as of midnight on December 31, 2028.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF SANTA MONICA DOES RESOLVE AS FOLLOWS:

SECTION 1. The City Manager, City Attorney and their staffs, consistent with the terms of the Consent Decree, shall take all actions necessary and proper to ensure that SMO will cease to operate as an airport and shall be closed to all aeronautical use forever effective as of midnight on December 31, 2028.

SECTION 2. The City shall not enter into any future agreements with the U.S., FAA, or any other party, that may have the effect of requiring the City to continue to operate SMO after December 31, 2028.

SECTION 3. The City Council directs the City Manager to ensure that the City provides 30-day prior notice to the FAA in accordance with 14 C.F.R. Part 157.5(b)(2) of

III.PROJECT DESCRIPTION / SCOPE OF WORK

To adequately plan for the future of the Santa Monica Airport, policy guidance and the economic basis for change must be clearly defined. The foundational roadmap for the post-closure future of the Airport will be identified through the scenario planning process that is developed in the RFP awarded from this RFQ short-list. The scenario planning process will develop several conceptual land use scenarios for the community and ultimately City Council's consideration, each centered around the idea of the site hosting a "great park." Each alternative will conceptualize the land use, design scale, transportation (including evaluation of regional transit connections to the post-closure Airport Park), innovation, and policy options for the future, as well as the financial impacts/benefits of each alternative. Among many things, the City is seeking a preferred scenario that is economically, environmentally and socially sustainable for several hundred years.

As a critical part of the scenario planning process, a market and economic analysis will be required to evaluate market feasibility of the different concept alternatives and the related financial implications and opportunities. The economic analysis will analyze upfront capital costs, life cycle and ongoing operational costs, and funding options to implement the various concept alternative scenarios. To the extent that any of the alternatives explore land use scenarios outside of the parameters of Measure LC, accompanying recommendations for clarifications or adjustments to LC will be required.

Most large-scale new parks of this size are not undertaken by small cities acting on their own due to the magnitude of the project and the associated capital and operating costs. The conceptual alternatives should investigate the feasibility of a Mello-Roos Community Facilities District, an Assessment District, and/or Enhanced Infrastructure Financing District (EIFD), and potential revenue generation from supporting land uses.

The Department is soliciting qualified professional individuals, firms, or multi-disciplinary teams with experience in any of the areas described below to assist in the development of its planning efforts. Coordination with City staff and the community is critical for the successful implementation of the project. Additional work tasks may be requested in the future depending on the specific needs of the City and available budget.

2014 Charter Amendment LC

640. Regulation, management and closure of Santa Monica Airport and future use of Airport land.

Subject only to limitations imposed by law, the City Council shall have full authority, without voter approval, to regulate use of the Santa Monica Airport, manage Airport leaseholds, condition leases, and permanently close all or part of the Airport to aviation use.

If all or part of the Airport land is permanently closed to aviation use, no new development of that land shall be allowed until the voters have approved limits on the uses and development that may occur on the land. However, this section shall not prohibit the City Council from approving the following on Airport land that has been permanently closed to aviation use: the development of parks, public open spaces, and public recreational facilities; and the maintenance and replacement of existing cultural, arts and education uses.



Public Process to Determine the Future of the Santa Monica Airport

C. PROPOSED PROCESS AND TIMELINES

Why Plan Now?

The process of identifying a resilient and sustainable future land use plan for the Airport that enjoys consensus with the community and is financially self-sustaining will take time. In order for the community to be ready for potential closure at the end of 2028 or shortly thereafter, the City needs to start planning and preparing now. Previous planning efforts could only consider uses and improvements for non-aviation lands, which produced several tangible projects such as the Airport Park Expansion design. Now, due to the Consent Decree, the entire property is available for reimagining. As such, the community will need to contend with a host of complex, interrelated issues that weigh heavily upon the site as one of the largest underutilized public land parcels in the whole of Los Angeles County and chart a course that allows future generations to reap the benefits of decisions made in present day.

Proximate to the potential Airport closure timeframe, the City will also be embarking on a number of substantial planning efforts that are mandated by State requirements, such as a major revision to the General Plan Land Use and Circulation Element (2030), a new 6th Cycle Housing Element (2029), and the need to carefully navigate the Surplus Lands Act that targets unprogrammed public real estate for affordable housing development. In following a process for a preferred use of the Airport land, the City and the community have the opportunity to design a roadmap "the Santa Monica Way" and to protect the community's interests in preserving character, scale, and quality of life.

It is also important to note that planning for the Airport may extend past the 2028 timeline. Staff is researching a scenario in which Airport closure precedes the adoption of a comprehensive master plan. In this case, aviation activities and related aviation businesses would likely cease operations and provide for interim uses while plan development continues. The economics of this scenario are currently under evaluation, as is the process for decommissioning a general aviation airport, which will likely need to be understood and planned for years prior to December 31, 2028.

Given the complexity of the effort, and the significance of the site to the community (and to some extent the region), staff recommends cautiously pursuing a multi-year community planning effort that begins with an exploration of interested and qualified professionals who can support the City in working with Santa Monica residents, property owners, members of the business community and other key stakeholders to define a multi-generational strategy to convert the Airport. To ensure a robust public process that will lead to a successful conclusion, Council adopted \$100,000 in the FY2022-23 CIP Budget and approved and additional \$1,000,000 for FY 2023-24 contingent on Council approval.
